In the event Farwest Corrosion Control and/or Corrosion Control Products determines the information contained in this credit application is false or misleading of any kind or nature, Farwest Corrosion Control and/or Corrosion Control Products may without further notice cancel any orders in house, or any deliveries in progress to applicant. Any false or misleading information by applicant shall be construed as a material default, and any invoices outstanding shall become immediately due and payable in full.
